OVERVIEW

A digital ecosystem and its underlying computing technology is dominated by mobile and cloud providers that spend billions of dollars per year for software, networks, processors, accelerators, memory, storage, and strongly influencing what is commercially available. As a result, T&E organizations are increasingly dependent on this ecosystem with diminishing influence over it.

While we understand that the dominant applications today are data-driven and artificial intelligence-based, to function in this ecosystem and assimilate the massive amounts of test data to facilitate knowledge discovery, T&E organizations must adapt people, processes, tools, and policy.

We must understand how to test at scale, how to assess data in place without transport to a central repository, how to adapt our organizations and processes to accommodate the inevitable incorporation (and sustainment) of machine learning test tools, and how to recruit, motivate, and retain a highly skilled workforce including scientists, engineers, technicians, and mechanics.

The Poster Sessions will be held during morning and afternoon breaks and evening receptions, co-located with the exhibits. Best Paper, Student Best Paper, and Best Poster Awards will be presented.
